I, CHRIS WATKINS, as a relevant person and enforcement officer designated by Newport City Council, consider that you, as the person responsible, are contravening a requirement imposed by these Regulations and it is necessary and proportionate to give you this Premises Improvement Notice for the purpose of preventing you from continuing to contravene the requirement(s) of the Regulations.

I am of the opinion that you, as the person responsible, for the premises detailed above, which is listed in Regulation 21 and Schedule 2 are failing to comply with the following relevant provision(s):

Regulation 21(2) of The Health Protection (Coronavirus Restrictions) (No.4) (Wales) Regulations 2020 for the following reasons:

Failure to comply with the obligations imposed on you by Regulation 21(2) 'Reasonable measures to minimise risk of exposure to coronavirus'.

Specifically, on 11TH November 2020 at 10:55

- HAND SANITISER WAS NOT IN A PROMINENT POSITION
- NO SIGNS DISPLAYED FOR CUSTOMERS TO WEAR FACE COVERINGS AT THE ENTRANCE
- NO SIGNS DISPLAYED FOR CUSTOMERS TO WEAR FACE COVERINGS INSIDE THE PREMISES
- NO CONTROL MEASURES IN PLACE AT THE ENTRANCE
- NO SIGNS DISPLAYED FOR CUSTOMERS TO SOCIAL DISTANCE AT THE ENTRANCE
- NO SIGNS DISPLAYED FOR CUSTOMERS TO SOCIAL DISTANCE INSIDE THE PREMISES
- NO FLOOR MARKINGS TO FACILITATE SOCIAL DISTANCING
- NO SIGNS OR FLOOR MARKINGS TO FACILITATE SOCIAL DISTANCING ON ENTRY AND EXIT OF THE TOILETS.

This Premises Improvement Notice is being given to you for the purpose of protecting against the risks to public health arising from coronavirus and the serious and imminent threat to public health posed by the incidence and spread of severe acute respiratory syndrome coronavirus 2 in Wales.

Which fails to ensure that other reasonable measures have taken place for the same purpose, contrary to Regulation 21(2)(b).

Failure to comply with The Health Protection (Coronavirus Restrictions) (No.4) (Wales) Regulations 2020, without reasonable excuse, is an offence under Regulation 35 and punishable on summary conviction by a fine.

In order to secure compliance Newport City Council hereby directs you to take the following actions:

- MAKE HAND SANITISER PROMINENTLY AVAILABLE AT THE ENTRANCE AND TILL AREA
- DISPLAY FACE COVERING SIGN AT THE ENTRANCE
- DISPLAY FACE COVERING SIGNS THROUGHOUT THE PREMISES, INCLUDING THE TILL AREA, IN THE PASSAGEWAY AND AT THE TOILETS
- DISPLAY QUEUE CONTROL MEASURES AT THE ENTRANCE
- DISPLAY TWO METRE SOCIAL DISTANCING SIGN AT THE ENTRANCE
- DISPLAY TWO METRE SOCIAL DISTANCING SIGNS THROUGHOUT THE PREMISES, INCLUDING THE TILL AREA, IN THE SKATING AREAS, IN THE PASSAGEWAY AND AT THE TOILETS.
- DISPLAY TWO METRE SOCIAL DISTANCING FLOOR MARKINGS AT THE ENTRANCE AND INSIDE THE PREMISES, INCLUDING OUTSIDE THE TOILETS.

Implementation of all actions identified in your COVID Risk Assessment.



Time Limit for Measures to be taken

The measures identified within this Premises Improvement Notice must be taken within 48 hours, commencing with the time that the notice is issued

It is an offence not to comply with this Premises Improvement Notice by the date stated.

Appeals

The appeals process is set out in Schedule 3 Paragraph 5.

A person to whom a premises improvement notice is issued may appeal to a Magistrates' court against the notice.

An appeal must be made:

- By way of complaint for an order, and in accordance with the Magistrates' Courts Act 1980(37), and
- Within 7 days after the day the notice is issued

A magistrates' court may allow an appeal to be made after the expiry of the period mentioned in b) above if satisfied that there is a good reason for the failure to apply before the expiry of that period (and for any delay in applying for permission to appeal out of time).

Notes

The Health Protection (Coronavirus Restrictions) (No.4) (Wales) Regulations 2020 are made under The Public Health (Control of Diseases) Act 1984 (as amended).

"Coronavirus" means severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2).

A "person responsible for carrying on a business" includes the owner, proprietor and manager of that business.

These Regulations expire on the 19th of February 2020. All requirements and restrictions will be subject to review by the Welsh Ministers every 21 days.

A Premises Improvement Notice may be issued to a person responsible for premises referred to in Regulation 21(1), if the officer considers that the person is not complying with the obligations imposed on the person by Regulation 21(2) and the measures specified are necessary and proportionate in order to ensure that the person complied with those obligations.

This Premises Improvement Notice is being issued under Regulation 26 and Schedule 3 of The Health Protection (Coronavirus Restrictions) (No.4) (Wales) Regulations 2020

Schedule 3 of the Regulations places a requirement on the Local Authority to publicise all Premises Improvement Notices.
